What is a Community Foundation?

A community foundation is a special form of public charity, organized to channel gifts from individual and corporate donors to a variety of charitable organizations in the local community. The first Canadian community foundation was created in 1921 in Winnipeg. Canada now has over 150 community foundations affecting millions of Canadian lives. Community foundations are the fastest growing, most dynamic form of philanthropy in North America.

When you donate to a community foundation, your gift is invested and the income from your gift is used to support charitable activities in Pinawa.

The Pinawa Foundation helps you support the causes that are important to you. You can be assured that all gifts will make a difference now and forever. The Pinawa Foundation has separate funds to support administrative costs so 100% of your donation goes to support Pinawa. Gifts are pooled and invested by our partner the Winnipeg Foundation.

Making a Donation

We accept donations by cheque or cash. You can also donate on-line by credit card using at the [Endow Manitoba](#) web site. The Foundation will use your gift to support the charities you specify. Before making a donation, please talk to your financial advisor to ensure that you and your estate receives the maximum tax benefit from your gift.

Your Ways to Give

Cash

Gifts of cash, whether by cheque, credit card, or currency, are the most familiar ways to donate.

Wills and Bequests

Individuals may provide for future gifts in their wills. A bequest could be a specific amount of money, a piece of property or a percentage of an estate. This gift is an important part of estate planning to reduce tax burdens on an estate.

Life Insurance

Donors may name the Foundation as the owner and beneficiary of a new or existing life insurance policy.

Securities

Tax relief may be available for donors who make gifts of publicly traded securities such as stocks, bonds and mutual funds. Donating securities can reduce capital gains which are normally taxed as income.

Named Fund

A donation over \$5000 can be named after a person, family or organization; the donor can advise us on the annual distribution of the income from the fund.
